Figures provided in response to "Total unduplicated headcount enrollment in degree applicable credit courses" (Question 7) include all credit-enrolled students. Previously all credit-enrolled students would have included some exclusively enrolled in basic skills English or mathematics; however, changes to placement and course sequencing have essentially eliminated the need to remove this vanishingly small subgroup of students.

Course completion data (Question 13) is for fall terms: 2017, 2018, and 2019.

IMPORTANT NOTE: The 2018-19 data for question 17 is still pending. We previously used transfer figures from the CCCCO Student Success Metrics (SSM) Dashboard to set goals and standards for transfer. The CCCCO is currently in the process of updating the SSM dashboard.
