President Miraglia read the land acknowledgement:

We acknowledge that we are on the unceded, ancestral homeland of the Ramaytush Ohlone who are the original inhabitants of the San Francisco Peninsula. As the indigenous stewards of this land and in accordance with their traditions, the Ramaytush Ohlone have never ceded, lost nor forgotten their responsibilities as the caretakers of this place, as well as for all peoples who reside in their traditional territory. As guests, we recognize that we benefit from living and working on their traditional homeland. We wish to pay our respects by acknowledging the ancestors, elders, and relatives of the Ramaytush Community and by affirming their sovereign rights as First Peoples.

Whereas, in the past several years, Academic Senate Executive Council elections have been non-competitive resulting in a council with fewer than the 29 members described in the constitution, and

Whereas, the 2023-2024 Academic Senate Executive Council has had productive conversations regarding the council membership and feels that dialog around membership should be continued into the next academic year, therefore be it

Resolved, that the 2023-2024 Academic Senate Executive Council recommends that the 2024-2025 Academic Senate Executive Council discuss Academic Senate Executive Council membership during both the Fall Plenary meeting in August and during regular council meetings and finalize proposed changes to the constitution in early Spring in order to meet the Spring '25 elections timeline, and be it further

Resolved that the 2024-2025 Academic Senate Executive Council apply what they learn as the result of being a much smaller representative body when having these discussions.
