President Miraglia read the land acknowledgement:

Amendment to <u>Resolution 2024.04.03.7A Gen Ed and Grad Requirement</u> <u>Outcomes Revision for Title 5 and Cal-GETC Alignment</u>

Whereas, on April 3, 2024, the Academic Senate Executive Council approved the Curriculum Committee's creation of GE (Title 5) and graduation requirement learning outcomes for CurrIQunet implementation starting fall '24;

Whereas, in <u>Resolution 2024.04.03.7A</u> outcomes A and B for Area 3A (Arts) use the conjunction "and":

- A. Explore <u>and</u> express the arts socially and culturally.
- B. Analyze the historical and social contexts of works of art.
- C. Evaluate the creative expression of self <u>and</u> others;

Whereas, on May 15, 2024, the Curriculum Committee was reviewing its first new Area 3A course outline, the newly proposed ARTS 113, and discussed that "and" in those two new 3A outcomes need to be "or" to address learning involving the creation of art or the examination of art, as was originally intended, not necessarily both concurrently;

Whereas, it's vital that this change be made in CurrIQunet immediately while other updates are happening and before the use of "and" creates tension and anxiety in future outline modifications; therefore, be it

Resolved, that "or" replace "and" in outcomes A and B used in the mapping of Area 3A (Arts) and implemented in CurrIQunet:

- D. Explore <u>or</u> express the arts socially and culturally.
- E. Analyze the historical and social contexts of works of art.
- F. Evaluate the creative expression of self <u>or</u> others.

a. <u>Academic Probation Taskforce Update</u> and <u>amended resolution</u> Mitra Sapienza, English faculty and Equity Coordinator, provided a brief update from the Academic Probation (now "Notice") Taskforce and the amended resolution for endorsement.

Resolution 2024.05.22.6A Amendment to Academic Probation resolution.

Whereas on November 29, 2023 the Academic Senate Executive Council passed Resolution on Decriminalizing Academic Probation Language initiating the convening of a cross-constituency taskforce to replace "Academic Probation" with less carcerial language and review instances where the college can change language and review policies and procedures as they relate to students' academic progress; and

Whereas, the taskforce has been meeting since December 2023, has developed a work plan to make updates and changes to Academic Probation by the end of May 2024 as outlined in <u>this workflow document</u>; therefore, be it

Resolved that ASEC endorses the taskforce, comprised of students, faculty, classified professionals and administrators, recommendation that CCSF change "Academic Probation" to "Academic Notice" in AP 6.22 and AP 6.30 the College Catalog, webpages;

Resolved that ASEC endorses the taskforce update the letter students receive when put on Academic Notice.

  - b. One-College One Book Adoption Nathan Steele, chair of the Faculty Professional Development Committee, brought forward *Ratchetdemic: Reimagining Academic Success* by Dr.

Christopher Emdin for endorsement as our book adoption for the 2024-25 academic year.

Resolution 2024.05.22.78B Adopting the One-College One Book Adoption

Whereas, Ratchetdemic: Reimagining Academic Success by Dr. Christopher Emdin is a timely book about pedagogies and serving the specific needs of minoritized students in a post-ish-pandemic world,

Whereas, dialogue about the book and the contended purpose of academia, including the role of educators and students in the context of community college, can help the college recognize the wealth of student experiences while exploring and committing to more equitable practices,

Whereas, adoption of the book will provide opportunities to dialogue on campus with groups, be in community with others, and collaborate with other stakeholders on campus, including Professional Development, Office of Student Equity, Strong Workforce Program, and Associated Students,

Whereas, those who attended Emdin's keynote on February 20th 2024 each received a copy of the book from OSE and the presentation received rave reviews from those in attendance; therefore be it

Resolved, that the CCSF Academic Senate adopt Ratchetdemic: Reimagining Academic Success by Dr. Christopher Emdin for the 2024-25 One College, One Book Project; and be it further

Resolved, that the CCSF Academic Senate invite our campus community to read, dialogue, build relationships, and collaboratively work toward a shared vision of the future with this book as a springboard for discussion of pedagogies and the institutional culture of our college.
