Survey distribution:


- Distributed in 2023 via e-mail, text message (SMS), and telephone.
- The survey addressed student perceptions of their CTE programs, employment outcomes, and how their coursework and training relate to their current career.

Survey participation:


- Credit:
 - 3129 students were surveyed and 940 (30%) responded
- Noncredit
 - 386 students were surveyed and 103 (27%) students responded

* Like other colleges providing noncredit programs in the State, due to COVID-related challenges in noncredit attendance data collection, fewer CCSF noncredit students with at least 48 CTE hours were surveyed.

Snapshot of other CCSF CTEOS Results

<u>Credit</u>

\$10.04 is the overall change in hourly wages after completing training—in dollars

44% is the overall change in hourly wages after completing training—in percentage gain

76% of respondents reported being employed for pay

31% of respondents reported transferring to another college or university

92% of respondents reported being very satisfied or satisfied with their training.

<u>Statewide results – Credit</u>

<u>Noncredit</u>

\$11.50 is the overall change in hourly wages after completing training—in dollars
51% is the overall change in hourly wages after completing training—in percentage gain
77% of respondents reported being employed for pay
23% of respondents reported transferring to another college or university
93% of respondents reported hours very
