Resolved, the Academic Senate recommends adding the following constitutional amendments and voting materials presented on December 18, 2024 for inclusion in the Spring 2025 Academic Senate Executive Council election:

- 1. Article III Membership Add the language "In an election where the number of candidates is smaller than Council seats available, these department limits shall be suspended. Members so elected will remain on the Council for a full term in subsequent competitive election years."
- 2. Article V Term of Office Increase the number of consecutive Council terms from two terms to **three** terms
